10TH EDITION OF CHILDREN FOR CHILDREN 2018 Annual Community Event Celebrates Children's Day for 1,000 Children with a Musical Treat and Visits to the S.E.A. Aquarium and The Maritime Experiential Museum at Resorts World Sentosa



- More than 400 pupils and teachers from CHIJ Kellock (Primary) come together for the 10th edition of a community outreach event co-organised by CHIJ Kellock since 2008 and will be staging an original musical production for the first time.
- Children for Children 2018 will see more than 1,000 children attend the musical and visit two attractions in Singapore: S.E.A. Aquarium and The Maritime Experiential Museum at Resorts World Sentosa.
- Children for Children 2018 fundraised a total of S\$337,793 for The Business Times Budding Artists Fund and will be graced by Guest-of-Honour, Mr Desmond Lee, Minister for Social and Family Development.

Singapore, October 4, 2018 - This October, 1,000 children can look forward to a day of fun hosted by pupils from CHIJ Kellock (Primary), who will also put up an original musical performance.

Children for Children (CFC), jointly organised by CHIJ Kellock, not-for-profit arts organisation and charity The RICE Company Limited, The Business Times and Resorts World Sentosa since 2008, brings children from across more than 50 schools in Singapore to celebrate Children's Day each year with a special outing to iconic attractions in Singapore.

Says Mr Tan Tee Tong, director of The RICE Company Limited, "*CFC* is an initiative that sees organisations and communities come together to do good for underserved children. It is also a platform to bring awareness to children about showing care for others, especially towards those in need. For 10 years now, *CFC* has become a highlight event in schools for the children, who are motivated by their teachers to work hard and are excited towards their special treat on Children's Day."

This year, 1,000 children will enjoy an inspiring musical production put up by the pupils of CHIJ Kellock from primary two to five. The production called 'Dreamweavers', also the theme of *CFC* 2018, will narrate an inspiring tale through original songs, dance and rhythmic gymnastics to encourage its audiences to seek out their dreams and let them take flight.

Says Ms Magdalene Chin, Principal of CHIJ Kellock, "Through this 10th edition of CFC, we hope to pay tribute to the originators of CFC with a musical production that hopes to inspire among our youths, a dare to dream and the courage to let their dreams take flight. The girls of CHIJ Kellock narrated an inspiring tale called "Journey to Your Dreams", through original songs, dance and acting. Among the cast, is a Primary Six student, Simorrah, who embodies what it means to pursue a dream despite the challenges of being in a graduating year, taking the PSLE. To spread the spirit of joy, gratitude, inclusiveness, service leadership and a good dose of hope to their peers, the girls of CHIJ Kellock published a storybook, "Wishing Upon a Star" and the CHIJ Kellock Student Volunteers played host to the children who visited The Maritime Experiential Museum and S.E.A Aquarium on Children's Day.

This CFC journey has taught the girls of CHIJ Kellock what it means to use their gifts in the service of others, what it means to be inclusive in their thinking and in their attitude and how dreams can be fulfilled with determination, optimism and will. These lessons, not always found in the classrooms, are what counts in shaping lives, and the girls of CHIJ Kellock are grateful for the experiences and opportunities of CFC."

Pupils from CHIJ Kellock will also play host to the children who will watch the musical staged at Resorts World Theatre, followed by a visit to the S.E.A. Aquarium and The Maritime Experiential Museum. At the S.E.A. Aquarium, the children will marvel at more than 100,000 marine animals of over 1,000 species including majestic manta rays, hammerhead sharks, sea jellies and poison arrow frogs. Over at The Maritime Experiential Museum, they will be guided through a series of curated activities such as learning about the rich history of the maritime silk route, colourful spice trade and perilous adventures of ocean explorers.

"We are delighted to welcome *CFC* back to Resorts World Sentosa especially on the occasion of its 10th edition. Conservation and education are at the heart of our many attractions where fun facts and fascinating insights are shared through immersive learning and exploration. RWS is very happy to co-organise this event and extend a meaningful learning journey to more than 1,000 primary school students from different backgrounds. We believe that our young friends will take home many valuable insights about their role in ocean conservation through the interactive activities by our S.E.A. Aquarium's conservation group - Guardians of the S.E.A.A., as well as how the maritime silk route has been instrumental to modern civilisation today," says Mr Tan Hee Teck, Chief Executive Officer, Resorts World Sentosa.

Since 2008, *CFC* has brought more than 10,000 children to various iconic destinations in Singapore such as The Singapore Flyer, the Singapore Zoo, Universal Studios Singapore and KidZania Singapore. The children are from primary schools islandwide who are on the Ministry of Education's (MOE) Financial Assistance Scheme (FAS).

CFC is also a fundraiser for The Business Times Budding Artists Fund (BT BAF), a fund that provides arts training and performing opportunities for financially disadvantaged children and youth between the ages of six to 19 to develop and nurture their interest in the arts.

Says Mr Wong Wei Kong, editor of The Business Times "CFC builds a virtuous cycle of giving and sharing between the community and those less fortunate in our society. This also inculcates in our young people the value of doing something special and meaningful to spread cheer and joy to their less privileged peers.
